

HEATHERWOOD VILLAGE SWIMMING POOL RULES

1. ALL RESIDENTS MUST WEAR THE PROPER POOL TAGS AT ALL TIMES.
2. NO RUNNING OR ROUGH PLAY.
3. NO GLASS CONTAINERS OR ALCOHOLIC BEVERAGES ALLOWED WITHIN FENCED POOL AREA.
4. NO DIVING IN SHALLOW END OF POOL (LESS THAN 5 FEET).
5. ONLY SMALL FLOATING ITEMS ALLOWED IN THE POOL AND SUBJECT TO POOL MANAGER'S DISCRETION.
6. NO PETS ARE PERMITTED ON POOL PREMISES.
7. PROPER SWIMMING ATTIRE REQUIRED. NO CUTOFF SHORTS.
8. THERE WILL BE A 10 MINUTE REST PERIOD PER HOUR.
9. COCOA BUTTER, BABY OIL AND OTHER HEAVY OILS AND LOTIONS ARE NOT PERMITTED DUE TO POTENTIAL EQUIPMENT DAMAGE.
10. MEMBERS ARE RESPONSIBLE FOR THE ACTIONS OF THEIR GUESTS.
11. ALL CHILDREN UNDER THE AGE OF 10 MUST BE ACCOMPANIED BY AN ADULT NOT UNDER THE AGE OF 18 YEARS OF AGE. ANY CHILD BETWEEN THE AGES OF 10 AND 12 YEARS OF AGE MAY ENTER THE POOL AREA UNACCOMPANIED BY AN ADULT, IF SAID CHILD HAS PASSED THE "SWIM TEST".
12. NO SWIMMING AFTER DESIGNATED HOURS UNLESS SPECIAL ARRANGEMENTS HAVE BEEN MADE THROUGH THE BOARD OF DIRECTORS. ANYONE CAUGHT SWIMMING AFTER HOURS WILL BE SUSPENDED FOR THE REMAINDER OF THE SUMMER AND HAVE TRESPASSING CHARGES FILED AGAINST HIM OR HER.
13. NO LOUD MUSIC AROUND POOL AREA.
14. NO PROFANITY OR VULGAR LANGUAGE WILL BE TOLERATED IN THE POOL AREA.
15. PLUG-IN ELECTRICAL APPLIANCES ARE NOT ALLOWED IN THE POOL AREA.
16. OBEY LIFEGUARDS AND OTHER SUPERVISORY PERSONNEL.
17. CHEWING GUM WHILE SWIMMING IS PROHIBITED.
18. SWIMMING WITH AN OPEN SORE OR A COMMUNICABLE DISEASE IS PROHIBITED.
19. JUMPING OFF BACKWARDS OR ANYWAY THAT THROWS THE HEAD BACK TOWARDS THE SIDE OF THE POOL IS PROHIBITED. FLIPS FROM THE SIDE OF THE POOL ARE NOT ALLOWED.
20. LIFEGUARDS ARE EMPLOYED TO ENSURE THE SAFETY OF THE SWIMMERS. THEY HAVE THE AUTHORITY TO REMOVE FROM THE POOL AREA ANYONE DISOBEYING THE RULES OR ENDANGERING THE SAFETY OF HIMSELF OR ANOTHER PERSON. THE LIFEGUARD HAS THE AUTHORITY TO SUSPEND THE OFFENDER FOR ONE DAY. ADDITIONAL VIOLATIONS WILL BE TURNED OVER TO THE BOARD OF DIRECTORS. REPEAT VIOLATIONS MAY RESULTS IN REVOCATION OF SWIMMING PRIVILEGES FOR THE REMAINDER OF THE SUMMER.

BABY POOL RULES

1. LIFEGUARDS ARE NOT RESPONSIBLE FOR THE SUPERVISION OF THE BABY POOL.
2. SWIMMERS MUST BE ACCOMPANIED BY PARENT OR GUARDIAN 18 YEARS OF AGE OR OLDER WITHIN AN ARM'S REACH.
3. PARENTS OR GUARDIANS ARE RESPONSIBLE FOR THEIR CHILDREN.
4. ALL POOL RULES APPLY TO THE BABY POOL.
5. SWIMSUITS REQUIRED. DISPOSABLE DIAPERS ARE NOT ALLOWED. LITTLE SWIMMERS OR PLASTIC DIAPERS ARE RECOMMENDED.
6. ONLY NON-SWIMMING PRE-SCHOOL CHILDREN 5 YEARS OR UNDER MAY USE THE BABY POOL.

DIVING BOARD RULES

1. ONLY ONE PERSON ALLOWED ON DIVING BOARD AT A TIME. DIVERS MUST WAIT FOR PERSON IN FRONT OF THEM TO GET TO THE SIDE BEFORE THEY DIVE.
2. NO SWIMMING IN DESIGNATED DIVING AREAS OF POOL.
3. ONLY 1 BOUNCE ALLOWED ON BOARD. JUMP STRAIGHT OFF BOARD. SWIM TO LADDER.
4. ONLY FEET ALLOWED ON BOARD, NO HANDSTANDS, ETC.
5. INWARD DIVES NOT ALLOWED, I.E., CUT-AWAYS.
6. YOUNG CHILDREN MAY GO OFF BOARD WITH PARENT PRESENT. CHILDREN MAY NOT DIVE WHILE WEARING FLOTATION DEVICES, GOGGLES, FINS OR MASKS, ETC.
